## HENRY WILSON MONUMENT.

This monument is erected by the soldiers of the army, by subscriptions from varions regi-ments,-started by enlisted men at Fort Vancouver, Washington Territory, January 28, 1876. It was intended "to testify their appreciation of the efforts of the late Vice President, Henry Wilson, in their behalf."

As chairman of the Military Committee in the Senate for twelve years, from 1861, to 1873, he had in various acts of legislation studied the best interests of the country and of the Army.

It is believed, that ir the soldiers had erected the most costly mouument to his memory, it would not have been as welcome to Henry Winson, if previously consulted, as this chaste, substantial, permanent monument, in harmony with his life and character.

It is in the grounds, in rear of the chapel, at the Soldliers' Home, Weshington, D. C. Built of granite-at base, 7 feet 6 inches by 4 feet 3 inches; height, 5 feet. Inseriptions in large raised letters-on front face, Henry Wilson the Soldier's Friend; on ópposite face, Erected by the Enlisted Men of the Army ; on the end, Died Vice President of the U. S., November 22, 1875.

The monument was completed in September, 1878 , in a very sitisfactory manner, by D. McMenamin \& Co., Marble workers, corner Penna. Ave. and 1st St. S. E.

The commissioners of the Soldiers' Home assented to its erection on the grounds of that institution. The executive committee, viz: the General, Lient General ant the three Major Generals of the army, approved of the plan, which has been executed by General Benj. Alvord, Paymaster General, the custodian of the "Henry Wirson Monument Fund."
