Mr. Brents introduced the following bill:

A BILL

For the construction, improvement, extension, and repair of the buildings, roads, and grounds at Fort Walla Walla, in Washington Territory.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That there be, and hereby is, appropriated, out of any money
- 4 in the Treasury not otherwise appropriated, the sum of forty-
- 5 two thousand dollars for the construction, improvement, ex-
- 6 tension, and repair of the buildings, roads, and grounds at
- 7 and in the vicinity of Fort Walla Walla, in Washington
- 8 Territory, including the construction and repair of the roads
- 9 between said fort and the railroad depot and other points in
- 10 the city of Walla Walla; and that the same be expended
- 11 under the direction of the Secretary of War.


