
Dear Sir - Could you ask Mr. McKinley

Dear beloved Brother in Christ Jesus:

Very much thanking you for the great kindness in sending me the introductions to the General Consuls of Frankfurt am Main and Berlin, I will not fail to tell you in the same time, how the dear Lord is keeping and blessing me. As you know, through my letter, I started with the Premer Lloyd Steamer "Grave" - Captain Carl Thalenhorst - on Tuesday October 13<sup>th</sup> inst. We had a passable voyage only 2 days stormy weather.

Sailing as a first cabin passenger I had the opportunity to get well acquainted with the captain. (Who claims with great joy to know you.) As Sunday came nearer, I did ask the Head Stewart, if the captain or who else was holding the Sunday service and as he replied: "no one" and said that there was no minister on board this time, who could hold the service,

I told him, that I felt very sorry about it and that, if nobody would take it up, I would do it with the Lord's help. The Captain hearing about it, was very glad, but did ask me, if I would be really able to lead such service. I showed him my references from different missions and your first reference (from 1893) recommending me as an Christian worker, he at once remembered you and gave his consent. Very kindly he offered to me the help of the music band, which I accepted and the song-books and with the help of the Head-Stewart I found a young Christian man in the 2<sup>nd</sup> cabin out, who was able to accompany the hymns upon the piano.

The service was set for commencing at 10<sup>30</sup> a.m. in the Salon of the 1<sup>st</sup> Cabin. Invitations and notices were given out by the order of the captain, to all passengers, officers and the crew, which were free from duty at this time.

In the morning at 8 o'clock a.m. the band was ordered by the captain to play over the whole ship, in the first and second cabin as well as in the steerage, beautifull chorals. Then at 10 o'clock a.m. the band commenced to play several hymns in the Salon of the 1<sup>st</sup> cabin, to call the people together. At 10<sup>30</sup> o'clock a.m. I addressed the meeting and gave out 3 hymns to sing.

Then I opened the meeting with prayer after which we had another hymn and than I read the precious word of our dear Lord: Isaiah 41 Chap. verses 10-13. and spokke about it, filled up by the Holy Ghost and confessed how my dear Jesus had saved me and how wonderfull he kept me ever since the hour He spokke peace to my soul. And that He is the same loving Jesus, as He has been from beginning and that He is willing to save every one - just now - as He has saved me, and that each one, has the privilege to come to Him, and that who soever calleth upon Him shall be saved — shall not perish, but have everlasting life. Than we had a song again and a finishing prayer. All this, the whole service was held by me, in the english language and after I had ended my prayer I asked, if not somebody in the audience would follow in prayer. After a little while my table and cabin neighbour arose (a rich gentleman from Barmen, Mr C. Paas, who is the owner of several large factories there) and commenced to pray in german and won my heart in storm, ever since we are very warm and good friends. Then I closed the meeting with: Praise God from whom all blessings flow.

The captain and all who were present (172 souls) seemed to feel much blessed, as I understood by their thanks and shake of hands.
