

Mr. Rockwell, President of the Midland Railroad do. of Staten Island says that you have made considerable investigation pertaining to the destruction of the mosquitoe pest in certain sections of the country.

For a month or two in the Summer we are troubled with mosquitoes in Prohibition Park. We have no stagnant water pools in the Park and no place that would in our judgment breed mosquitoes, unless 15 would be from a stream running through the lower part of the Park, which at times runs rather slowly, but it seems to be a pretty strong stream. The lower part of the Park after heavy rains is quite wet and damp for several days.

Mr. Rockwell tells us that on your advice. I think, that he used last year crude oil which he sprinkled over ponds in the neighborhood of Midland Beach, and that it worked very satisfactory. Would you recommend that we sprinkle the whole of the ground of the lower part and these streams with oil, and if so how often? Also do you think it will assist in any way to get rid of these pests?




