Dear General Howard:

Your good letter came to hand here, yesterday, forwarded on from Northfield. I read it with deep interest, and sent it back this morning to Mr. Moody, who will have check forwarded to you at once. I feel General (and I am sure thousands will feel the same), that you have sacrificed a great deal, in the time you have given, and the risks you have run, for the Commission work. Much of its success is due to you. You will have, I am sure, the reward you most crave, in the thought of the hundreds of soldiers and sailors who have been won for Christ. I am thankful to God for answering prayer, and bringing you home safely. I was concerned about you, as

the reports of prevalence of fever came from Santiago. My own condition has proved more serious than I thought it was, when I left Chickamauga. I seem to have got full of Malaria; I have lost forty pounds in weight, and have no strength; I seem to be pretty well, but cannot walk up a hill without exhaustion, and find it such a slow process to build up. I am, however, getting better here, and hope to be at work either at one of the Camps, or raising money, in a few days. I was able to tell them a little of the work, in the Chapel here last evening, and they gave me \$16.00, which I have just enclosed to Mr Moody. I had letters last week from Key West, Jacksonville, and Chickamauga, and all were full of encouragement. Conversions continue with all the workers. Huntsville Ala, was the point mentioned by the Chickamauga letters, as the place where most of the men were to be gathered. We have provided for men to go there, - and also to Lexington Ky, and Knoxville Tenn.
