

My dear General:

Night before last Mrs. Sladen and I went up to see Grace and the children. I say up, because they have lately moved up pretty close to the hills at the south end of the town, and it is pretty well up in the world. They have a very nice place though, as pretty as any they have ever lived in, and the house is, my wife says, a very convenient one. And then the children have not a very long walk to school. The Captain has gone, as of course, you know. He telephoned me a few hours before he went away, and was, I thought, rather blue about going off so far and for so long a time. That I could well imagine. I told him that I would look after his family and do everything in my power for them that was necessary, and that he must tell Grace to call upon me for anything she needed, and that if her funds did not come regularly or were delayed, to let me know and I would see that she wanted for nothing. This seemed to relieve him, for it was pretty hard for him to leave them all so far from others of her own family. Grace, however, is always very brave, and I as Mrs. Sladen have remarked again and again. And her children all seem such a help to her and so much comfort. She really takes a very happy view of life, though she has been so much alone.

Now I must thank you for your thoughtfulness and kindness to Frank. He was so grateful to you for calling upon him, and inviting him out to the house of your friends in New Haven. It is a great thing for a strange boy there to have some one living there upon whom he can call. He was very happy over an invitation that your friends gave him to call again.

Now, General, in reference to the Lincoln Memorial University, I wish I could feel able to make a contribution towards it, but at present I

am not able to do so; what with two boys at college, and an added piece  
of property to my residence lot, I am run about as close to my in-  
come as I can get. I feel that you are very much interested in the  
success of the project, and I hope I may be able to give something  
towards it some time, but I am not just at present.

We have Carrie and her two children living with us while her hus-  
band is on active service as a volunteer quartermaster on a trans-  
port running between Manila and San Francisco, his real rank being  
that of 1st Lieut in the 14th Infantry. Fred is still serving as an  
Aide on Gen. Otis staff, and is more than glad to be seeing active  
service, though he complains that he does not get enough of it at the  
front. Foolish boy. I hear from Grace that Harry is going through  
his final examinations in the law. And now, I suppose, he will be a  
full-fledged lawyer. I imagine you will be soon be all returning  
to that delightful home in Burlington.

Capt. Bradley's ship, by the way, carried out the 21st Infantry, and  
Carrie, who was in San Francisco while he was there, saw many old  
friends, Major Boyle amongst the rest.


