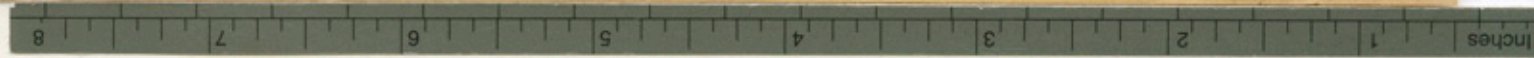

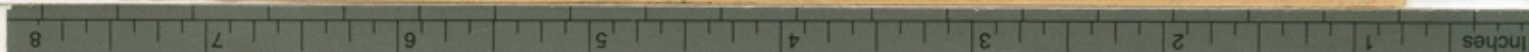

You wrote me that you must have destroyed it as you could not find it among your papers. In my office in San Francisco, I have the cancelled check and the copy of my letter to you, which I will look up and forward to you, when I have opportunity.

We anticipate moving to Los Angeles the first of the month, and if so, I shall remove my offices to the Douglas Building here. I do this so as to be nearer the Southern mines in which I am interested, and of which company I am the Managing Director.
