He entered the army in the permmer of 1862, and during the whole time has never expressed a wigh or desire where to be placed on duty, but has gone cheerfully to fill all his appoments. I have spared a good maring of my family, for the wellfore and good of my Country, Three sons that have been in the lorny, in one capacity or another all through the war. I gave them all up cheerfully and stand home with three daughters and one little Son, and was in the Cumberland Valley, when the Rebels made a vaid towards Flarreshing. I never desparred nor doubted the success of night and freedom. And now I semply ask can't you appoint my hushand on duty worth, before the weather becomes very warm in the South. 
