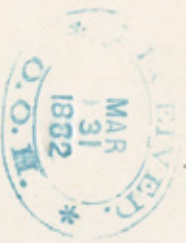

Dear General,

Thanks for the correction
of the initial. I read the letter H as K.
I was rejoiced, together with others of your
friends here, at the characteristic sentiment
or rather expression you utter in regard
to the Chinese bill. It receives an
echo in the breast of every lover
of right and justice. Nothing can
be more directly opposed to the letter
and spirit of our Constitution than
that bill. It is in vain to talk necessity
and utility. What is radically wrong
can never be made right, however you
may twist it. I forward you
a local paper containing the sermon

of the Rev. Dr. Van Slyke, one of
the most eloquent of our city clergymen,
on this topic. Should you be able
to find the time to read it I am
sure it would please you.

I also forward you two papers from
San Francisco and Southern California.
The Hon Thomas H. Brents is urging
the admission of Washington Territory
in the House. I trust if successful
that they will not embody anything
against the Chinese in their new
Constitution. There is hope that
the President may yet veto the bill.

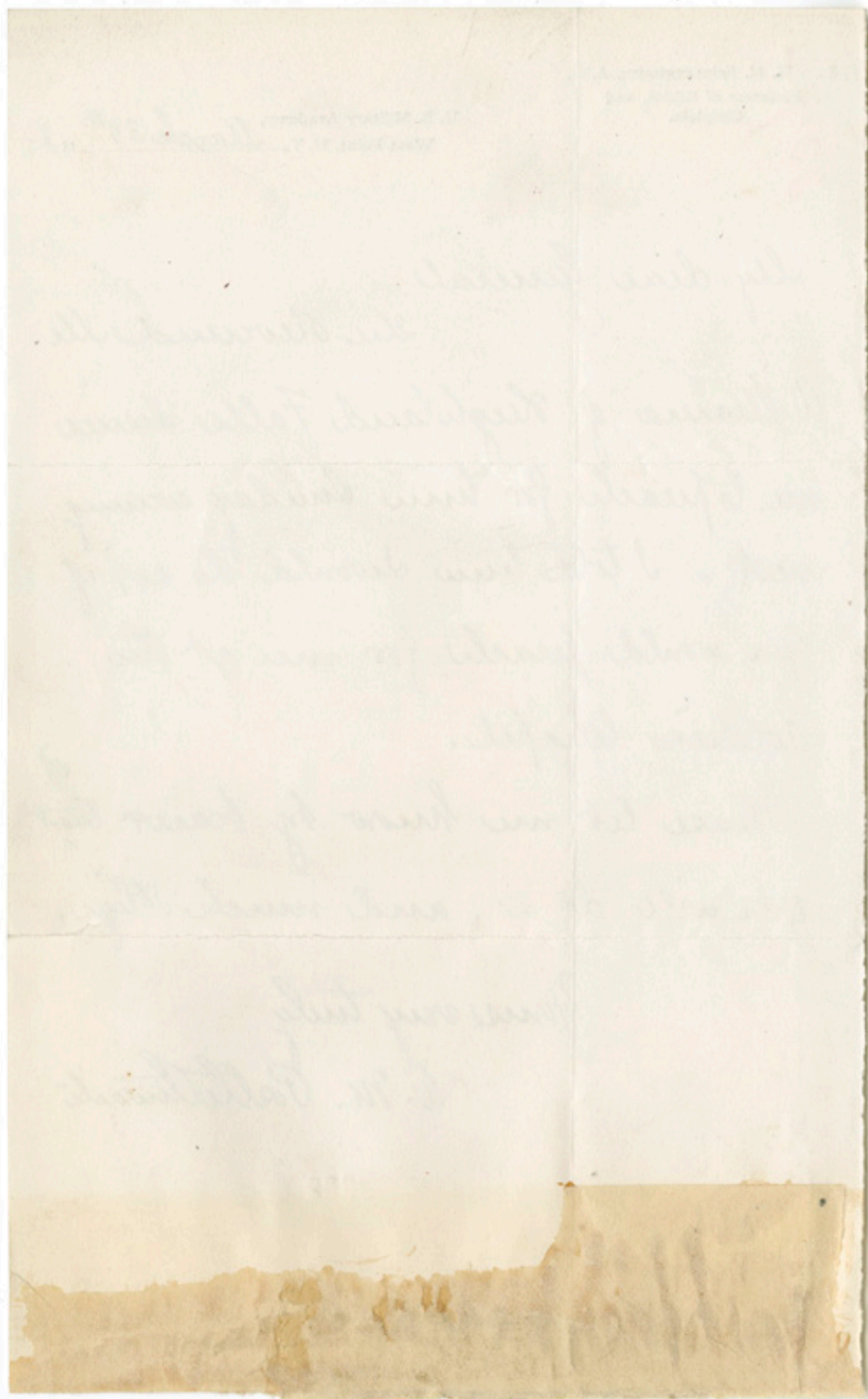
