DEAR SIR :

I enclose herewith a copy of Senator Manderson's bill of last winter providing for a three-battalion (twelve-company) organization for the Infantry arm of the service, together with extracts from the reports of the Secretary of War and the Commanding General of the Army favoring such organization.

As no doubt it is generally conceded that such legislation as this has a broader scope than most if not all that has been proposed for some time past, I venture to ask you in common with all the ~~other~~ Infantry officers in the service (who are likewise addressed,) to use the enclosed paper, coupled with such arguments or reasons of your own you may have to advance, in a direct appeal to such Congressmen or other persons of influence whom you may know, to aid the cause, when the bill is again introduced in the 49th Congress.

The following is an extract from a recent letter from Senator Manderson to me :

"It is my intention to introduce the bill at the next session of Congress, and I hope to be successful in procuring its passage. The petition referred to—[meaning the petitions of officers forwarded last winter at the instance of officers of 2d Infantry—C. H.]—will be laid before the committee on military affairs.

It would be well for all army officers favorable to the bill, to write personal letters to such members of Congress as they may know, urging them to give the bill support."

I should be pleased to know your views and actions on the suggestion made herein.

## THREE-BATTALION ORGANIZATION OF THE INFANTRY BRANCH OF THE ARMY.

"48th Congress, 2d Session.

"S. 2442, Manderson.—To increase the efficiency of the Infantry branch of the Army.

"Whereas, experience has shown that the three-battalion organization of the Cavalry and Artillery branches of the Army is the most useful in time of peace, and best adapted to expansion in time of war:

"Therefore, be it enacted, etc., That Section 1106 of the Revised Statutes of the United States of America be amended so as to read as follows:

"Each infantry regiment shall consist of twelve companies, one colonel, one lieutenant-colonel, three majors, one adjutant, one quartermaster, one sergeant-major, one quartermaster-sergeant, and one chief musician, who shall be instructor of music, and two principal musicians. The adjutant and quartermaster shall be extra lieutenants, selected from the 1st or 2d lieutenants of the regiment: Provided that all appointments to the original vacancies above the grade of 2d lieutenant created by this act shall be filled by seniority in the Infantry arm of the service."

The foregoing bill was introduced in the United States Senate by Senator Manderson of Nebraska, during the 2d session of the 48th Congress, but owing, no doubt, to that being a short session, and there being much other business before Congress, the bill failed to receive definite consideration. As Senator Manderson, at the 1st Session of the 49th Congress, proposes to again introduce the bill, in the interests of the service, the subject is now revived and somewhat in detail, in the sincere hope that as thus presented, it may receive from its friends the united aid and earnest attention and action that it is believed its importance warrants and deserves.

That there should be a common organization for the three fighting branches of the Army would seem no more or less than a

natural, reasonable, and logical proposition. If the premises as laid down in this bill are substantial and true—and they are supported by the best of expert testimony, as shown by this paper,—the rest naturally follows.

In connection with, and germane to, this subject, it may be said with force and fitness, that the efficiency of the Infantry arm of the service suffers vastly by reason of slowness of promotion, which evil will, in a considerable measure, be remedied by the passage of this bill. At present, the Infantry is materially behind the Cavalry and Artillery respecting promotion, a condition resulting greatly from the difference of organization, which discriminates against the Infantry.

In support of a bill of the character specified, the following weighty official opinions are quoted:

Extract from the Report of the General of the Army for 1883.

"On the 8th of February, 1884, I will attain the limit of age fixed by Congress for military service in the Army, and I purposely asked of the President the privilege of anticipating this date to enable my successor to make such recommendations as he may deem necessary; but before leaving I beg to record an expression of opinion that it will be found wise to provide a common organization for all arms of the service, viz:

That each regiment of infantry be composed of twelve companies, the same as now with the artillery and cavalry, making three battalions, each of four companies in time of peace, and of eight in time of war; that each company shall have a hundred men; and that in time of peace two of these battalions (eight companies) shall be maintained on a perfect war footing, whilst the other battalion (four companies) may be a mere skeleton, with its complement of officers, and used as a nucleus for recruits. In this battalion can be placed the officers and soldiers

invalided by hard service or sickness, and such as are not weaned of home influence or family importunity.

Were such an organization (thus briefly sketched, but more elaborately described in former reports) to be sanctioned by Congress, the military peace establishment could, I believe, be maintained on the present estimates, and would possess the inestimable advantage of admitting of an increase without "disorder or confusion" to 6,000 artillery, 12,000 cavalry, and 30,000 infantry by the mere scratch of a pen and the magic wand of money; and afterwards by doubling the enlisted strength of each company without the further addition of a single officer we should have the respectable force of 95,000 men, a force large enough for any probable necessity during the remainder of this century.

The militia and volunteers of the States would soon follow suit, and we should have throughout the country these small handy battalions of four companies, instead of the large cumbersome regiments of ten companies,—a bad tactical unit, and in practice always scattered."

Extract from Report of the Secretary of War for 1883.

"The report of the General of the Army has a special interest in being the last annual report that General Sherman will make. At his own request he has been relieved from the command of the Army, preparatory to his retirement from active service under the Act of 1882. He has therefore thought it best to refrain from making any new recommendations in his report, leaving that duty to his successor in the command of the Army, Lieutenant-General Sheridan. He, however, calls attention to and renews a former recommendation that a new organization be adopted for the

regiments of infantry, so that each shall be composed of twelve companies, making three battalions of four companies each, each company having one hundred men; and that in time of peace two of these battalions shall be maintained on a perfect war footing, while the other battalion may be a mere skeleton, with its complement of officers, and be used as a nucleus for recruits. The great advantage of this change, as suggested by the General, is the important one of being able to put a large and effective force in the field, on short notice, by merely enlisting a sufficient number of additional private soldiers, the officers and organization being always ready to receive them."

Extract from Report of the Lieutenant-General commanding the Army for 1884.

"The discipline of the Army is excellent, and I have no schemes to present for its reorganization.

For many years of effective service it has been organized substantially as now, and were I called upon to recommend any change whatever, it would be simply to make a uniform organization for the three arms of the service by adding two companies and the corresponding majors to each regiment of infantry."

Extract from Report of the Secretary of War for 1884.

"The Lieutenant-General renews the recommendation of General Sherman that there should be made a uniform organization of the three arms of the service by adding two companies with the corresponding majors, to each regiment of infantry.

The reasons for this change were given at some length in my last report, and I concur in the recommendation of the Lieutenant-General."



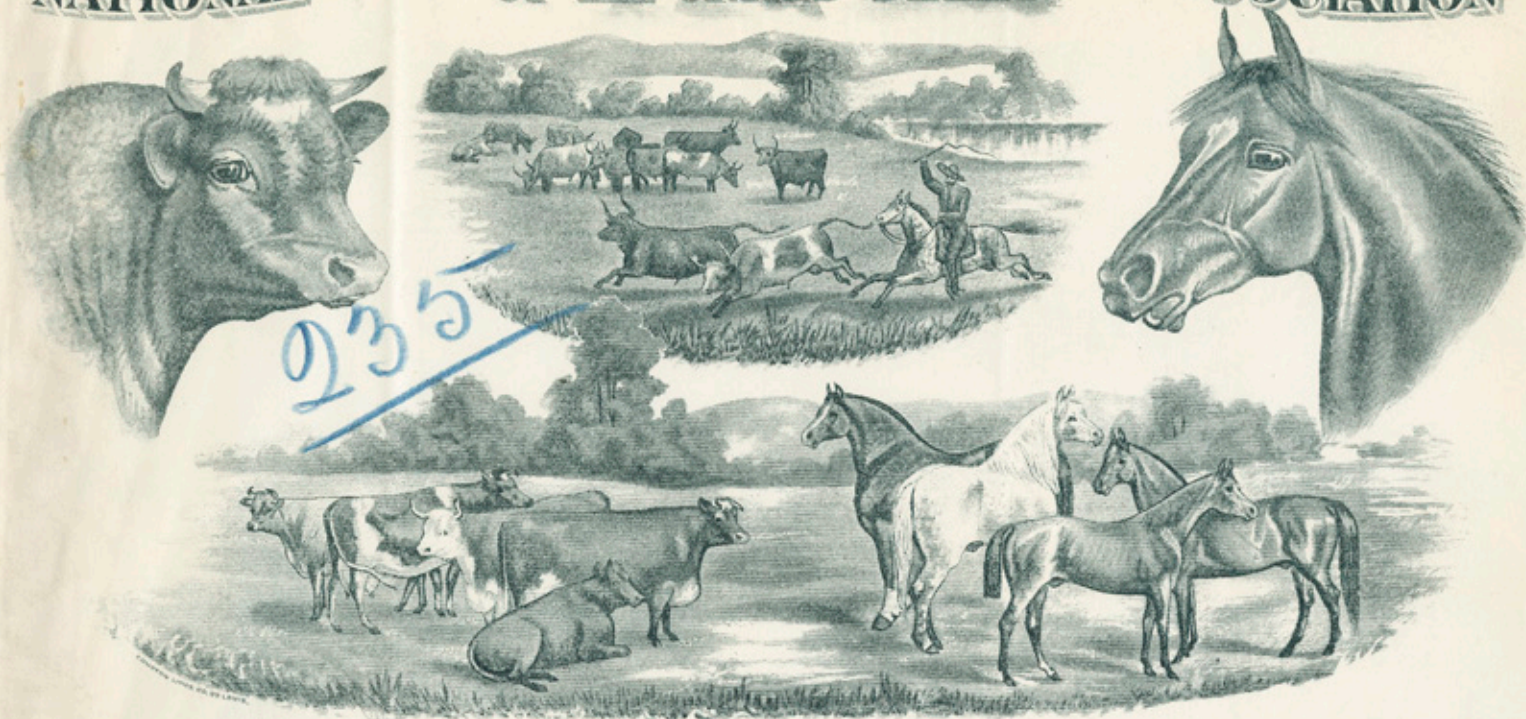

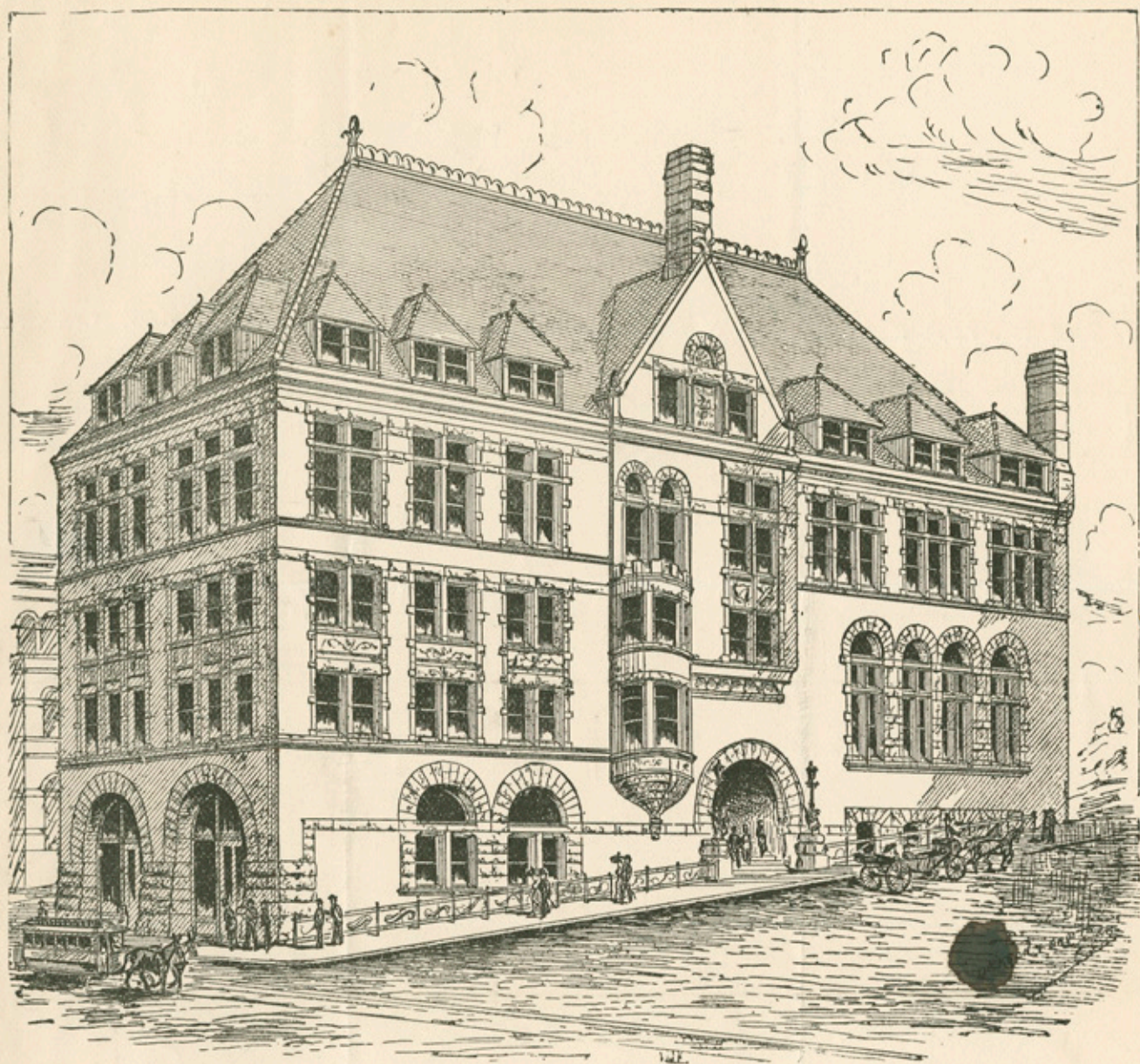

As you will no doubt be in  
Washington between now and March next and at  
times have occasion to see the President Confidentially  
I wish to present some facts to you in the interest of  
Phil Howard's promotion. I am doing this without  
his knowledge and may be without his approval  
As you are not fully conversant with Army matters  
and this one especially, let me inform you that on  
March 16<sup>th</sup> next Major Phil John Pope will retire  
being sixty four years of age. Phil Howard being the  
senior Brigadier General, should be made Major  
General. The custom of seniority in the Army promotion  
is so old and just there is little use for me to  
discuss its fairness. This alone without any other facts  
should induce the President to do justice. If the  
Civil Service truths of the President are applied in  
this matter there can be no doubt of General Howard's  
promotion, but I must tell you before I go further that



Frederick Howard has enemies in high places and they are working to defeat him. Two, if not all the Bulgarian Generals are striving to obtain promotion over him. It is enough for you to know these facts without going into details. I am convinced the strife will be a strong one and I doubt whether Frederick Howard will do any thing. He must stand on his record. That alone will be sufficient provided the President is not unjustly influenced. So far as impartial history is concerned Frederick Howard is the Peer of all who would defeat him. So far as my information goes in the service a large majority desire his promotion and will regret to see so long established principles overruled or so worthy an officer overruled. You must also take into consideration the fact that Frederick Howard has a large following in civil life that are factors in political life well worth retaining on the side of this administration. They belong to all parties and are large in doubtful states. As the other aspirants and his enemies will use every thing to defeat him, a due regard should be paid to Frederick Howard's influence in civil life and it should be the one and felt by the administration. You are so well informed on the

late war it will be useless to recount his conduct or recall the fact that Congress long since recognized his service in saving us further misadventure at Vicksburg. Knowing you are a friend of the President and would not have him make a mistake I write freely. Knowing Frederick Howard and the Ministry I feel I am but doing justice in putting the President's friends on guard. If you think as I do and I am sure you will you will not only take a personal and public interest in the matter but you will interest Mr. Dickinson and all your friends on this subject. I shall write Frederick Howard enclosing a copy of this letter and in the mean time you can think it over. If he approves <sup>of the means I have taken</sup> I will write you. He no doubt will do so for there is nothing unfair or unjust in such action but on the other hand I feel I am doing what I would like a brother officer to do for me without solicitation. Some time since I put Frederick Howard on his guard regarding the matter but I do not think he has made much headway aside from standing on his merit when the time comes.
