The people are out on the streets in every conceivable attire & with all kinds of instruments shaking the heavens with their noise. The colored people, are wild with gladness. Hats painted red, rosters in craze right side up & upside down on the hats, some on poles, between two men carrying them fishing poles on the shoulder & banners on the legs, flags

of all sizes as badges, inscriptions
of all kinds; horns predominant,
are furnishing music, canons
are firing, small bells are
ringing, & cheers & shouts that
are loud & long & hearty - The
utmost good humor prevails
& the victors are without stint
enjoying their picnic - I have
looked on & laughed until my
head aches; & sides are sore
& I have come in for re-
lief - The old veterans can
hardly rejoice enough - but
they will, probably before
they get through - Nearly 200
car loads of people are on
their way here from Ohio
& Ills. & the jubilee has just
commenced. To me nothing
this side of Gettysburg has
ever compared with it -
You can imagine how

very sad I am, in the
 midst of it all. It did me a world of good
 when I called on the Gen-
 eral to have him speak so
 kindly of you, & send you
 such a loving message,
 & today I wrote him a note
 of congratulations, & told him
 that we Choflains had been
 supported & sympathized with
 by you, the Christian Soldier,
 & now we instinctively turned
 to him the Christian President.

I feel that as God through
 the people have elected him,
 that God & the people will
 love & support him -

I shall remain here
 until next Thurs. (the 15th) &
 then begin my journey home
 word - I will be glad to get

home again —
I hope that you Mrs Howard
& the family are all well.


Dear Sir


