



of relatives longer.


This is my object in






Dear Sir - On Saturday

The present officers of the Department were appointed from the following states:-


N. Y. 4; Pa. 3; Ohio 3; Va., Md., Mass., Me., Ky., Vt., one each, and one from the Army.
