
I forwarded

for concerning the Indians.
It has seemed to me that
the location of these Indians
near Hampton, Va., would
be putting them in a favor-
able climate. Mr. Harding,
when here, last week, spoke
of the "Sherwood" farm of
Eight hundred acres as



possessing many advantages - I think 800 acres quite sufficient for them, & if their children could be sent to the Hampton School, this would be one very good reason for selecting "Sherwood" - I am sure that if sent West, say to Kansas, with a large reservation to roam over, they would imitate their old ways of living as much as possible. Of course, not much can be done ^{with those} who have reached maturity, but rapid progress will be made with the younger generation. If you look upon it favorably, I should like very much to accompany the

Indians when they go on to look at the location, if such be contemplated. I don't think there would be any trouble about supplying my place with a medical officer from Jackson Pks. or ^{St.} Augustina. I should like very much to see these Apaches located in some good place, since their conduct has been so very praiseworthy during their confinement at this Post -

If you were to withdraw your acceptance & declination both & write me that you would further consider the matter, and then in two or three send your final decision, the Board could elect a


man whose services it "would enlist." I think it would be better for the University than to elect one at the special







It would be wholly useless for me to go again to see Miller. He dont seem to me to amount to much anyhow.


