My dear General Howard:

Permit me to remind you of your kind promise, under date of June 28th, to attend our Annual Meeting at Northampton, Mass. Oct. 21-23, and deliver a brief address at the closing meeting, Thursday evening, Oct. 23. My dear General:-

I propose, with assent of majority of Committee, to have edited and printed under the care and supervision of Captain Kingsbury, a pamphlet of the dinner giving all the speeches, toasts, etc. as they were, some being not reported at all and some only partially so.

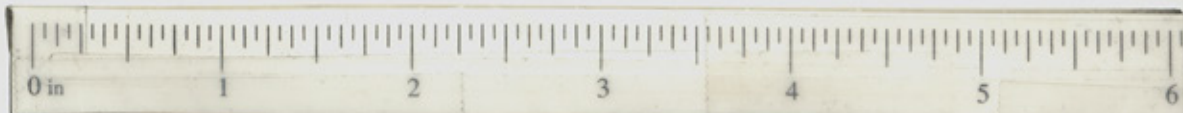
