

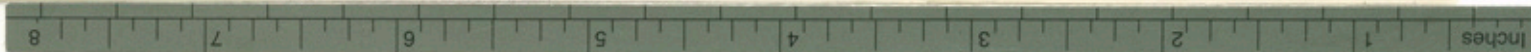

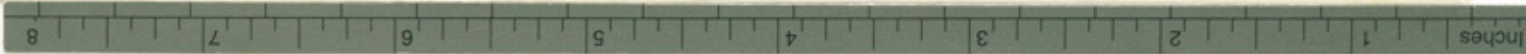

While in Paris I will stay in the student quarter where I have an artist friend, a Portland boy, who knows just where to go from long residence there. A lady friend here who has lived in Europe is going over on the Friesland at the same time that I do. That is one reason for my selection of that steamer. Another reason is its cheapness. I can buy a round trip, 1st Class, for \$95.⁰⁰ and return if I wish by either the same ship or the Inman line from England.

My dear uncle Eli's. —

My love for you and my respect for your opinion is so great, that I hate to differ from you in opinion but I think it is a wise thing for me to go abroad next August and study for the winter in Florence, seeing as much as I can of architecture while I am away. I have consulted my employer Mr. Stevens and he has assured me that he will have a place for me if I want it, at advanced pay, next Spring when I return. He thinks it will be the best possible thing I can do for my "architectural development". I have also consulted the music committee of the First Parish church

Here and have been assured by them that I can have the position of bass in their choir if I study singing while in Florence. This is one of the best positions in town and much sought after by singers. The present bass is an old gentleman and retires next Spring. I have consulted my singing teacher here also and she says that it will be an excellent thing for me and that I will be able to command good pay when I return. Last but not least, I have the money deposited in the bank, sufficient to cover my expenses.

Mother insisted upon paying me what father owed me in such a way, that after repeated refusals, I accepted the

amount, five hundred dollars. I have three hundred beside and by August 1, shall have another hundred to add to it.

I intend to lay out a course of architectural reading to do, and to draw a great deal. Italy is the centre of the architectural interests of the world and my "Tech" studies have fitted me to appreciate what I see there. I shall be in Florence from the first of September till the middle of May following or thereabout, taking three lessons a week in singing and living in an Italian family in order to do it cheaply and to learn the language well. I cannot get in this country what I can there.

CENTENNIAL CELEBRATION

OF THE
Discovery of the Columbia River,
May 11th, 1892.

To be Held at Astoria, Oregon, and Vicinity,

May 10th, 11th and 12th.

Tuesday, May 10th.

First—Reception committee will meet pioneer organizations and invited guests at 6:30 A. M. at the Union Pacific wharf in Astoria, Or.

Second—Address of welcome by the mayor of Astoria, responded to by visitors at Ross opera house at 10 A. M.

Third—Excursion for guests to Fort Stevens and the government jetty at 1:30 P. M.

Fourth—Parade civic societies and exhibition drill by the Astoria fire department, at 4 P. M.

Fifth—Musical concert at Ross opera house, at 8 P. M., also literary exercises at Odd Fellows' hall at 7:30 P. M.

Wednesday, May 11, 1892--Centennial Day.

First—National salute at sunrise of fourteen guns, representing the number of states in the Union on May 11, 1792.

Second—Imitation ship Columbia to leave Flavel's wharf with specially invited pioneer guests, at 9 A. M. Will proceed to the entrance of Columbia river, abreast of Cape Hancock; then returning.

Third—Convoy, consisting of all steamers, tugs, sailing vessels, fishing boats and other water craft in the harbor, will leave Astoria at 9:30 A. M., meeting ship Columbia abreast of Fort Stevens and escorting her to anchorage—of 100 years before—near Point Ellis, 3 miles north of Astoria.

Fourth—12 M. grand salute of the assembled multitude, cheers by the people, national anthem by the bands, and chorus of whistles by the fleet and all the whistles and bells within sound and sight.

Fifth—Answered by 100 guns from men-of-war or Forts Canby or Stevens, and by use of telegraphic signals by the steamer whistles and bells throughout the United States.

Sixth—Oration by Professor John Fiske, and poems and literary exercises at the Ross opera house, at 2 P. M.

Seventh—Sunset salute of forty-four guns.

Eight—Grand marine torchlight procession by steamers, tugs and fishing boats in front of city of Astoria, to start at 7:30 P. M., returning to wharves at 9:30 P. M.

Thursday, May 12th.

Visiting points of interest and excursions to Forts Canby, Ilwaco and Seaside Resorts.

The above general program for the celebration was adopted by the Columbia River Centennial Society, held in Portland, February 25, 1892. Newspapers throughout the Pacific coast are requested to notice or publish the above.
