Dr. Burrell says, he will "be on hand up to 9 o'clock, and my heart will be with you until the remainder of the evening." Rev. Dr. John Hall writes that he is engaged to lecture at Princeton, and adds that "my sympathy was entirely with the Society." Ira D. Sankey says he cannot be present, but adds "success to the Temperance Cause to Brother Howard the new President."
