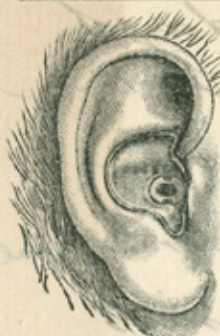

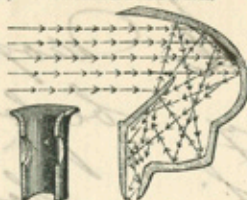

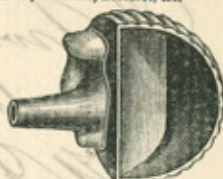
Ear Piece for each ear, with Tubes, Vibrating Membranes, and Air Chambers, for constant use.

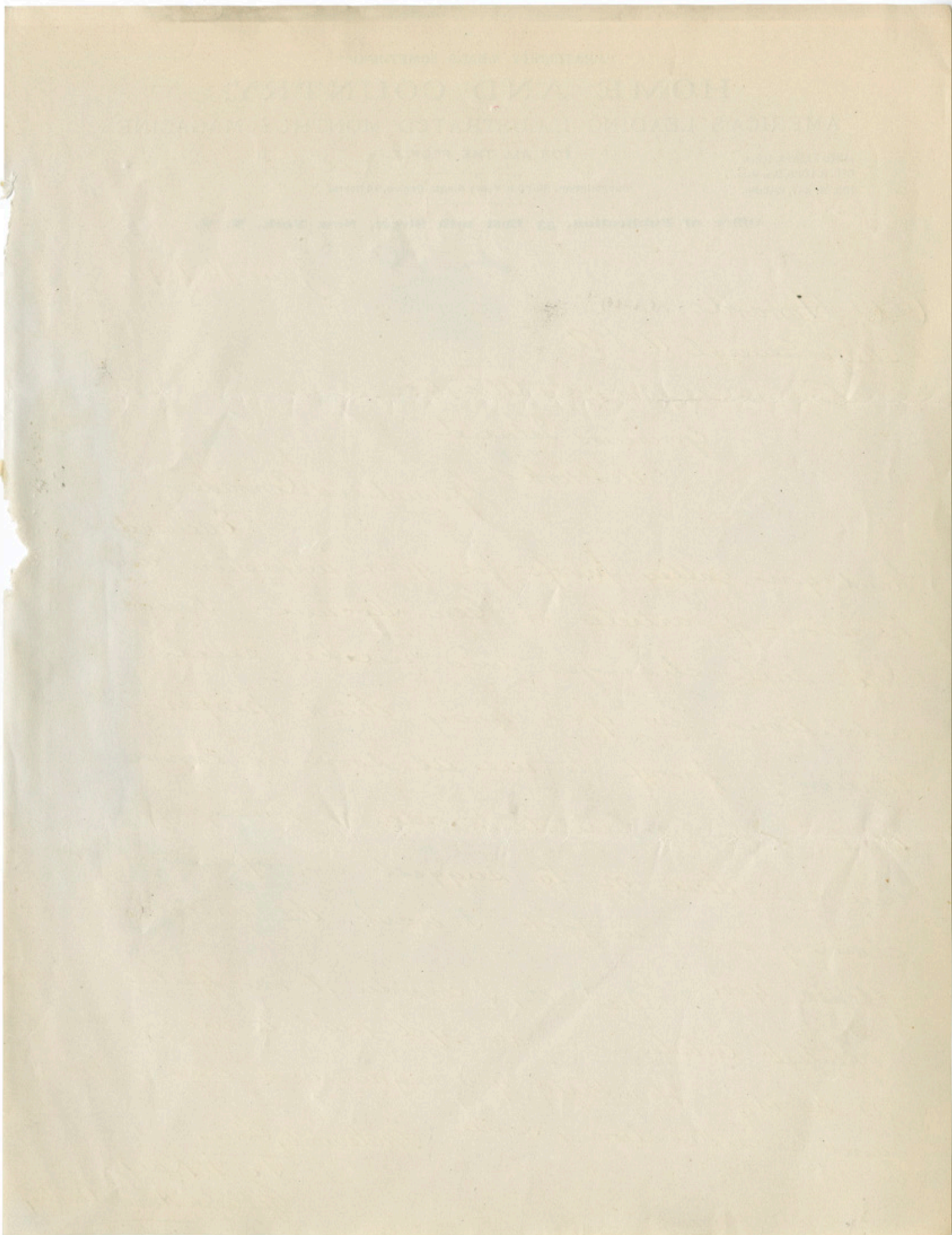
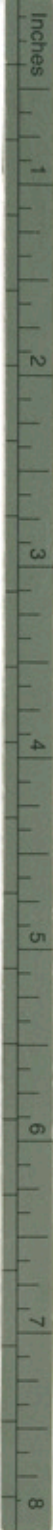

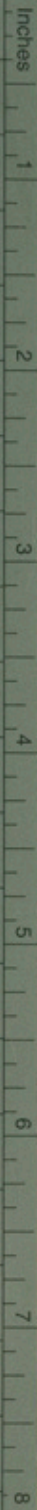
