### FIFTY CENTURIES IN FIFTY DAYS ON A CHAINLESS BICYCLE.

Aug. 26th, Mr. J. C. Knowles of the Kings County Wheelmen, Brooklyn, started to ride 3000 miles in 30 consecutive days, 100 miles each day. He selected a route running from the Club House on Bedford Ave. Brooklyn, to Oakdale Station, L. I. and return, and chose for his mount a CHAINLESS BICYCLE. The following is his record for each day:

Sept. 19th 3 3/4" of rain fell between 8 o'clock in the morning and five in the afternoon, yet during the rain and the severest storm that has visited Long Island in five years, Mr. Knowles, though at times running through water several inches deep, covered over 10 miles an hour. On completing the 3000 miles his machine was taken apart and the bevel gears examined. The gears did not show the slightest wear and although at times riding through water above the crank hanger, the bicycle ran as smoothly as the day it left the fcatory. After completing his task of riding 100 miles each day for 30 consecutive days, Mr. Knowles decided to continue riding until he had completed 50 centuries, which ended Oct. 14th. It was observed that more than one half of the time was either windy or stormy, and that notwithstanding this fact, Mr. Knowles' average riding time for the first 30 centuries was 7 hrs. and 53 mins. and for the last 20 centuries was 6 hrs. and 49 mins. making an average of 7 hrs. and 27 mins. for the entire 50 centuries.


