

I have the honor to ask your attention to the inclosed application for widow's pension by Mrs. Josephine M. Wilson, of Chicago. I knew her husband, the late Capt. James I. Wilson of Company "C," 36th Illinois Volunteer Infantry. That regiment was in my command in the Fourth Army Corps, Army of the Cumberland. Ido not need to identify him, as he had for some years received a pension before his death as referred to in Mrs. Wilson's application. Capt. Wilson was associated for some years with my brother in business, and was almost totally deaf and as stated by Surgeon Pierce of his regiment, this deafness and a diseased state of the pervous system was plainly the result of his severe illness while in the military service. In support of this fact, and also of the fact that his death resulted from the same causes and is directly traceable to his suffering and hard service in the campaigns in Missouri and Arkansas, I invite a careful examination of the affidavit of Dr. Sam'l K. Crawford, formerly Surgeon of the 50th Ohio Vol. Inf. Dr. Crawford is still a well-known physician in Chicago, and held important positions as a staff surgeon, I am told, as well as Surgeon of the 50th Ohio Vol. Inf. Dr. Crawford states that he knew Capt. Wilson in 1865, and that it was evident at that time that the impaired functional operations of his brain and nervous system had resulted from exposures in the swamps of Arkansas, and resulting sickness.
