Our indebtedness now amounts to about \$3,500<sup>00</sup> in notes and accounts. Besides the \$1,000<sup>00</sup> credit voted to Mr. Myers, and the claim of Mr. Kehr, I have tried to secure a loan to pay the amounts most pressing, and have succeeded, through Mr. James, in arranging in New York for a loan of \$1,500<sup>00</sup> at 6% for 90 days or 4 months, provided I will endorse the note; but he concludes his letter by saying "I want one thing understood, I am not to be bothered with these matters, I have too much on hand. I discounted the small notes, (\$200<sup>00</sup> and \$100<sup>00</sup> for Dr. Larry) here, & now I guarantee the \$1,500. loan, that is if you put it through, but I will not be bothered any more," besides this warning, no one here will join with me in endorsing, and I do not think that I
