Dear General Howard :--

It gives me great pleasure to advise you of the phenomenal spiritual interest already developed in many parts of the country as the direct result of God's blessing upon the work of our National Central Committee. We began the past week with a meeting of ministers and laymen of the Christian churches of New York City and vicinity, held at the 23rd Street Branch Y. M. C. A. About 300 persons were in attendance, notwithstanding the many other "end of the century meetings" in progress throughout the city. Rev. Drs. David James Burrell, George T. Purves, J. Wilbur Chapman, W. F. McDowell, Cornelius Woelfkin, and Mr. William R. Moody, made splendid, inspiring addresses, with damediate results in decisions by ministers present to engage in the movement. During the week noonday services were held at the Marble Collegiate Church; afternoon services by the five associated churches of the Methodist Formard Movement; and other services in a number of churches, all in response to our Appeal. Communications have been received through the mails indicating a very wide extent of interest throughout the United States. Rev. Dr. David James Burrell, Mr. F. H. Jacobs, and your Chairman attended a conference of Christian ministers and laymen in the City of Philadelphia, on the 4th inst. in the interest of the movement. At that conference a Philadelphia Executive Committee was organized with Rev. Dr. Floyd W. Tompkins (Rector of Holy Trinity Church) as Chairman; former Governor Robert E. Pattison, as Treasurer; and Rev. W. C. Webb (State Secretary of the Evangelical Alliance) as Secretary. A Philadelphia General Committee was also organized with Bishop Cyrus D. Foss (Methodist Episcopal Church) Chairman, and Rev. J. B. Ely (Secretary of Presbyterian Evangelistic Committee) Secretary. Pursuant to the suggestion of your Chairman, it was also decided to consider the appointment of district committees to take up the work in each one of the 18 districts of the city. The conference making these appointments was of extraordinary interest and power, and it was the expressed conviction of many in attendance that the campaign would doubtless prove a mighty success.

We are pleased to mention the wide notice given the movement by the public press. Calls are now coming in from leading religious newspapers for articles about the work, and are being given



the attention they deserve. The New York City organization has been in process of formation for several days, and we expect to report by the end of the present week that it is completed. Owing to the press of other matters, the organization of the sub-committee on finance has been delayed. If the members of our Committee may be pleased to interest some of their friends financially in this great work, or if they may consider it a privilege to send our Treasurer a check for the same purpose, we have no doubt but that God will most richly bless the givers.
