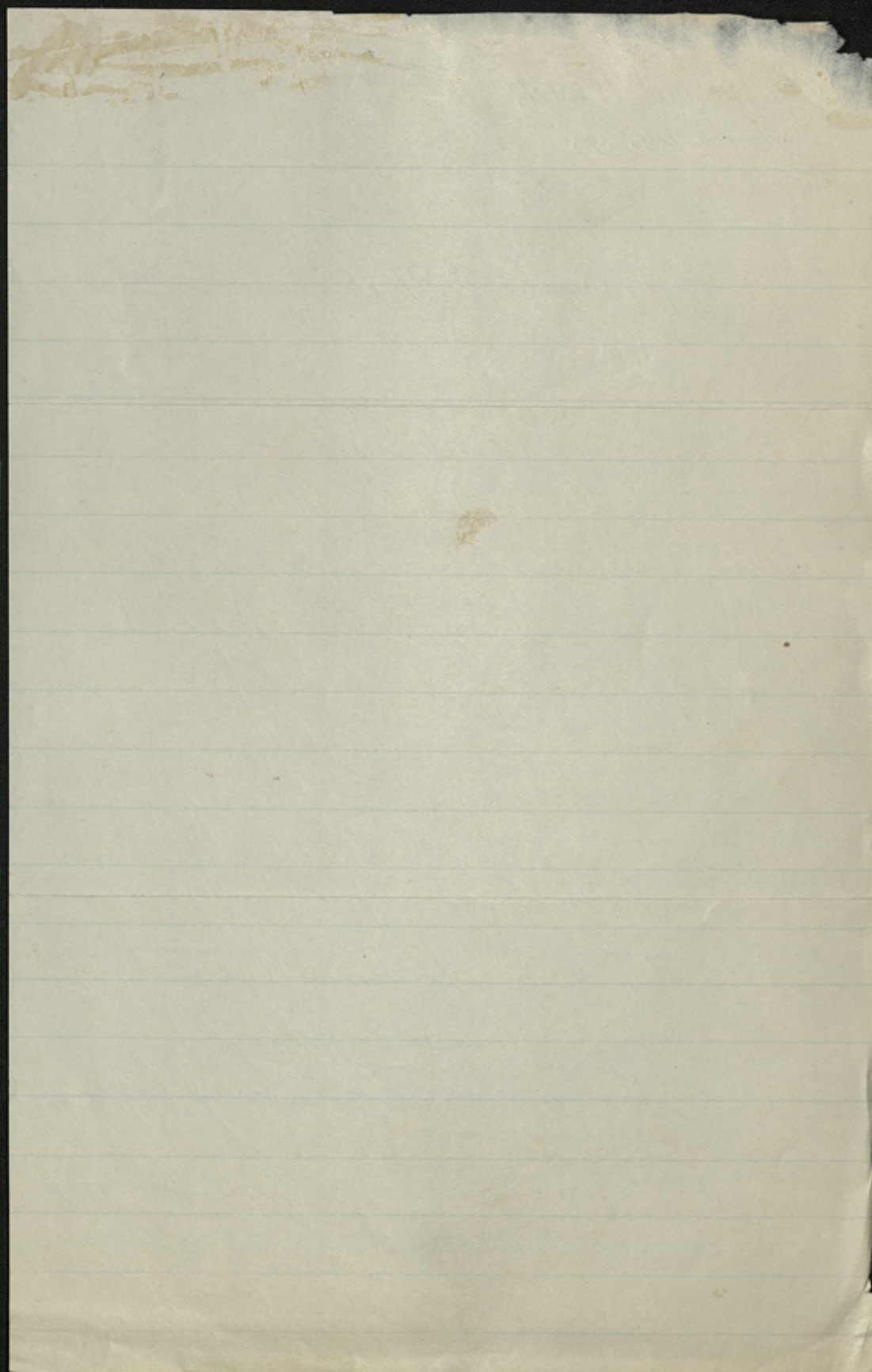
Dear Gen. Howard,

Come praying for the guidance of the Holy Spirit.

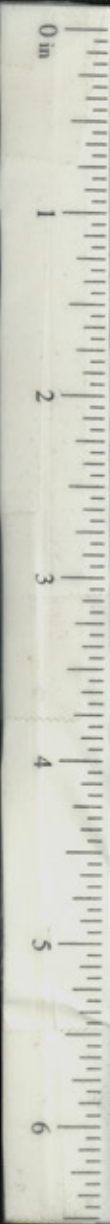

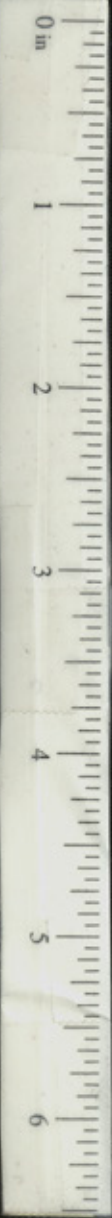

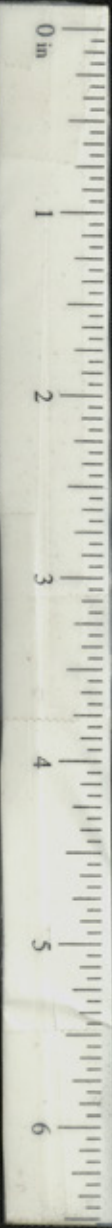
