Yours received and contents noted. You will have noticed, I am sure, that it was not in the thought of the opponents of the canteen to not do something constructively for the benefit of the men. We believe it will pay the Government from every standpoint-- from that of discipline and efficiency, health and per consequence money-- to make the post exchange system, including the various features suggested, the most attractive place at the post and to do it under the auspices of the Government and with the people's money, without compelling the men to be beer drinkers and beer sellers in order to get what both sides concede will be to their advantage.

Inasmuch as this has always been our thought and we are about to ask definitely for such provisions under the Quartermaster's and Commissary Department's heads in this year's appropriation bill, I should be very glad if you will be willing to give us a word of general commendation, which we can use in connection with others from such people as General Daggett, Captain Munson, Captain Brooke and I hope also from Generals Merriam, Wheeler et al., both of whom I know to be friendly to the project. I have taken the liberty of enclosing a draft which will cover the case and which I trust contains nothing to which you would object.

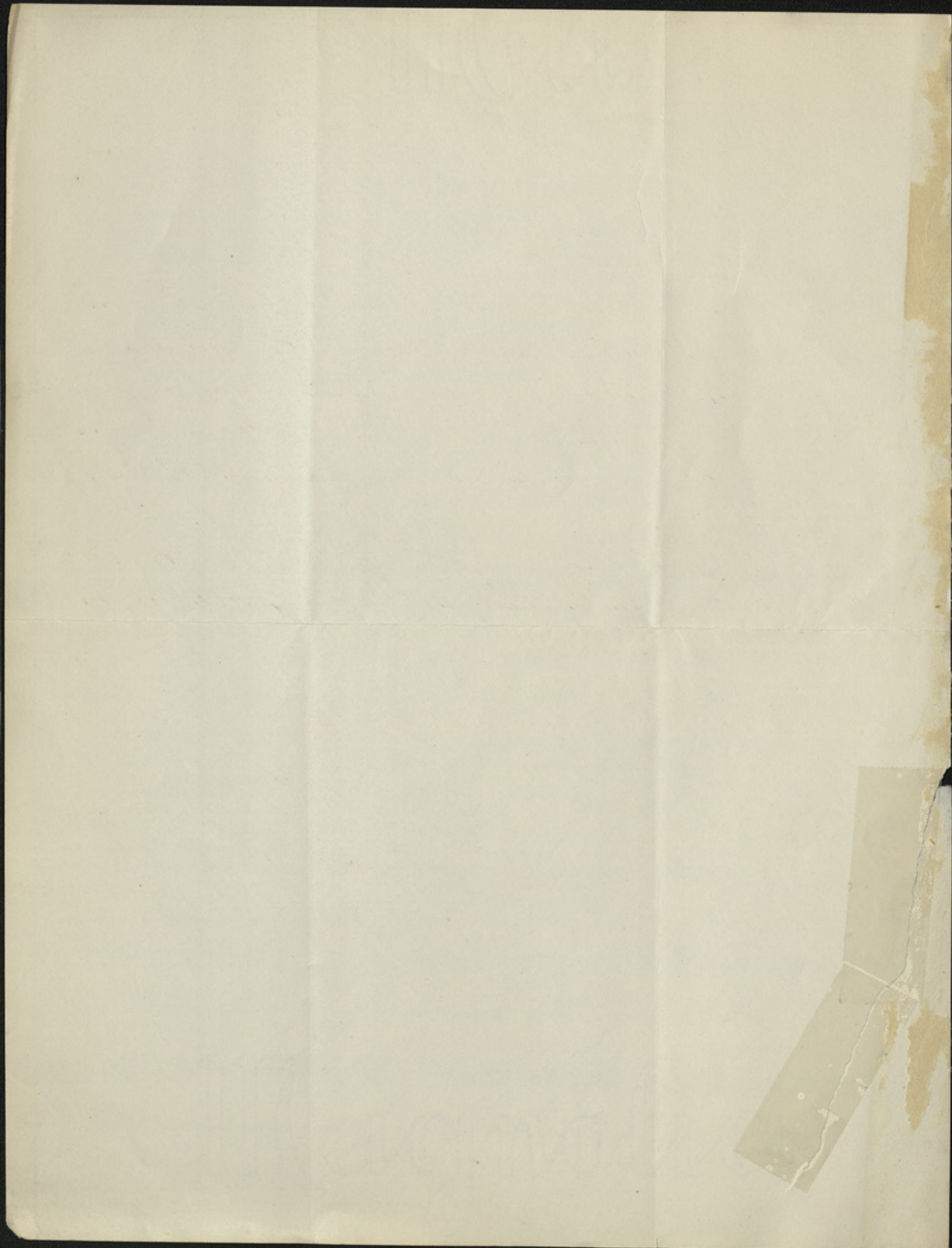
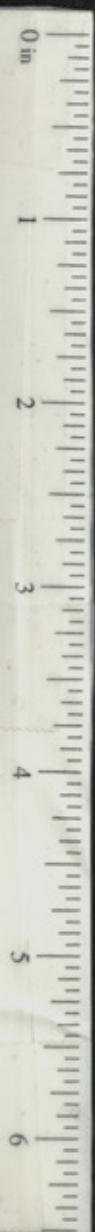
My Dear General,

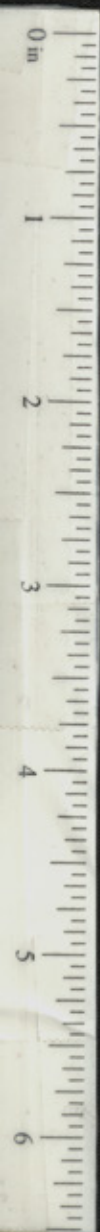
