This to Grand Army Men, is the event of the year, when the memories of the days that called us originally together are encountered, the old stories told, and the old songs sung.






For the construction and maintenance of suitable buildings at military posts and stations already established and occupied for the conduct of the exchange store, school, library, reading, lunch and amusement rooms, gymnasium, etc., to be expended in the discretion and under the direction of the Secretary of War, One Million Dollars.

Difference between the cost of the ration at twenty five cents per day and the amount of twenty seven and a half cents per day, to be issued to the Company or Detachment Commander of each Company or Detachment for each enlisted man while present for duty with his Command, and to the surgeon in charge of a hospital for the sick while under his care, in the proportion of seventy five cents per month per man, to be used and disbursed by them as Company, Detachment or Hospital funds, to take the place of the funds heretofore accumulated from the profits of the canteen; this sum to be separate and distinct from funds accruing from savings in the articles of the established ration, Six Hundred and Seventy Five Thousand Dollars.


Dear General:





Respected Sir:-
