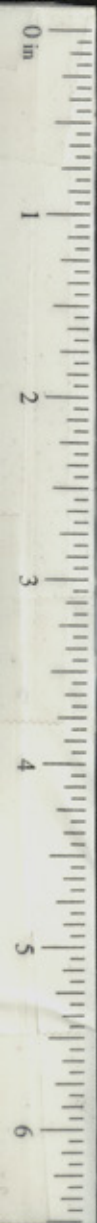

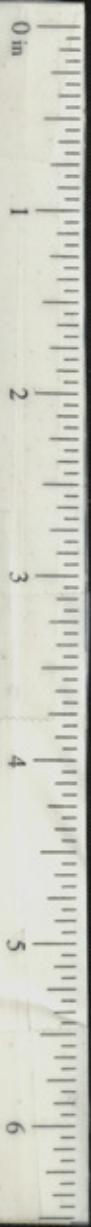

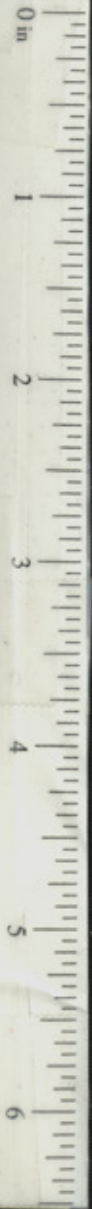

the guest of the City - and old soldiers and citizens

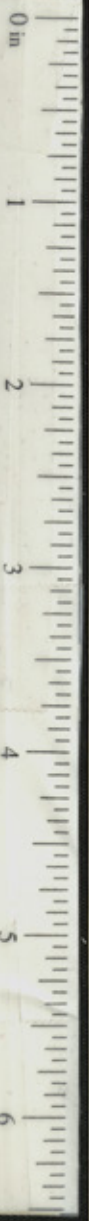

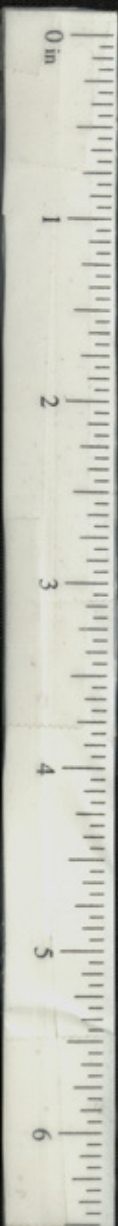
General O.O. Howard:

The flag was the Division
Headquarter flag on Logan's
headquarters and became the
property of my father "Col. J.
C. Douglass," 78th Ohio V.V.I.,
3rd Division, 17th Army Corps.

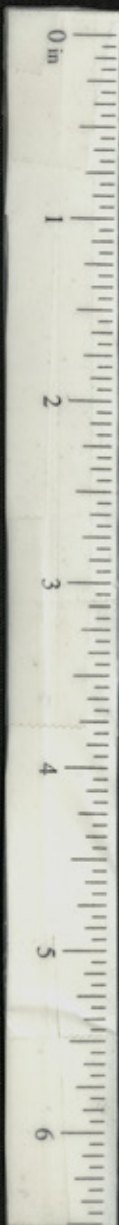


You were at one time in command of that division, I believe.

The question is - Do you remember any thing about the presentation of the flag to my father? We have many valuable war papers but none telling the history of this act.

Another question is - "Would it be possible for my brother to sell this flag to enable him to overcome a business difficulty?" We had thought some National Historical Society would value it - it is a thirteen foot flag with blood stains, torn

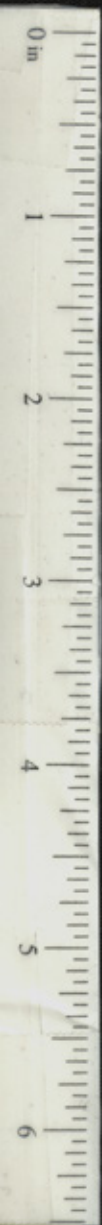
with shot and shell, still tied with rags used to fasten it to the flag-pole in the parade at Washington in the grand muster out. It was used on Quartermaster's Dep't, or else over Logan's own tent.

My father was on General M.D. Leggett's staff, at Vicksburg, and went with Sherman to the Sea.

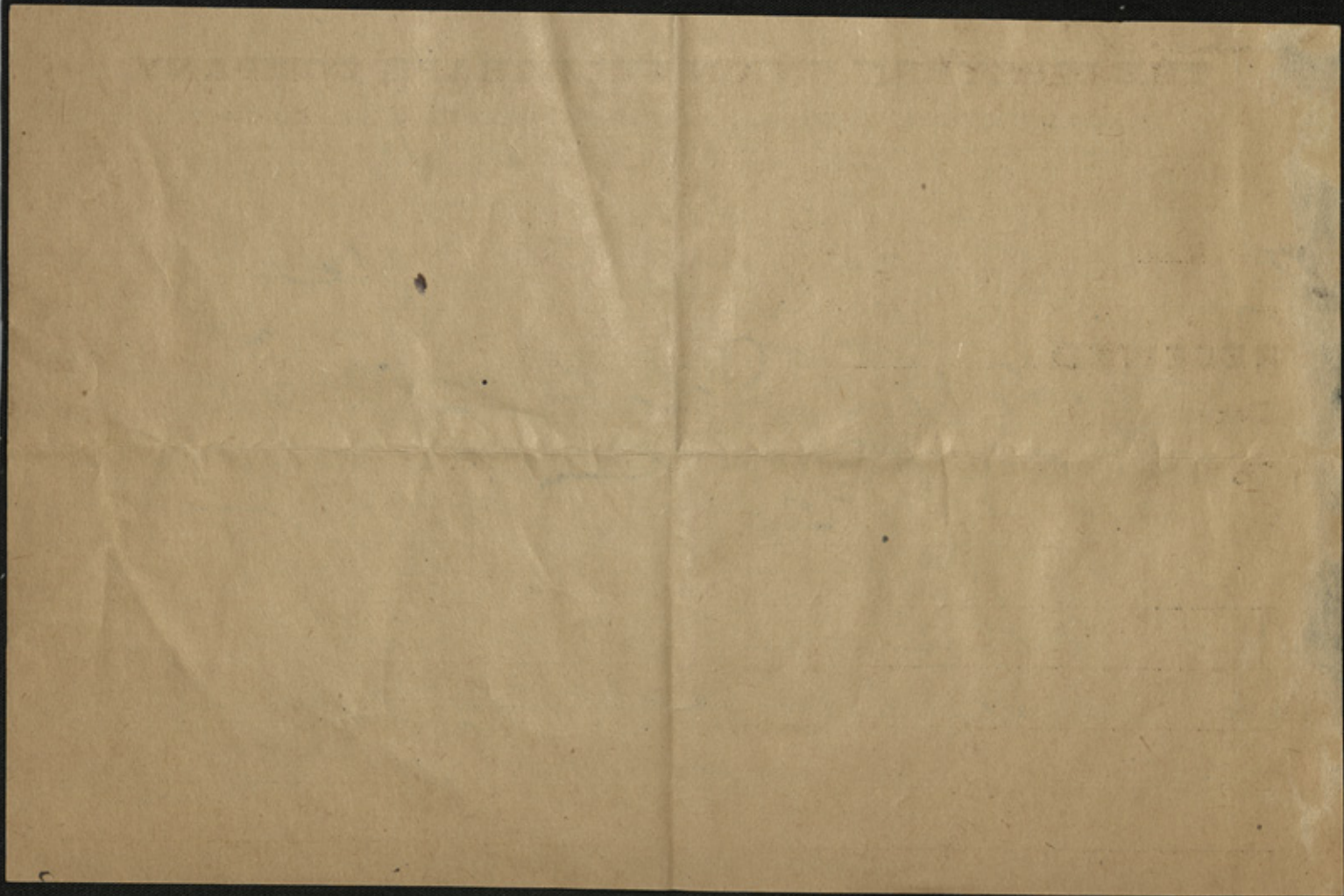
