Pardon my intrusion but believe a reply will be of much value to the son of a soldier of the army of the Jennessee. The flag was the Division Headquarter flag on Dogan's headquarters and became the property of my father "Col. J. C. Douglass, 78th Ohio V.V. J., 3rd Division, 17th armyborps.




you were at one time in com mand of that division, I be here. The question is - Do you remember any thing about the presentation of the flag to my father . We have many valuable war papers but none tilling the history of this act. Unother question is - " would it be possible for my brother to sell this flag to enable him to overcome a business difficulty?" We had thought some national Historical Society would value it - it is a thirteen foot flag with blood stains, tom



with shot and shell, still tied with rags used to faster it to the flag-pole in the parade at Washington in the grand muster out. It was used on duartermaster's Dep't, or else over Dogan's own tent. My father was on General M.D. Deggett's staff, at Vicksburg, and went with Sherman to the Dea. Hoping your patience is not over taxed, and assuring you of high respect due a soldier, and a Christian soldier, I remain Respectfully More. Rev. J. M. Wilson.
