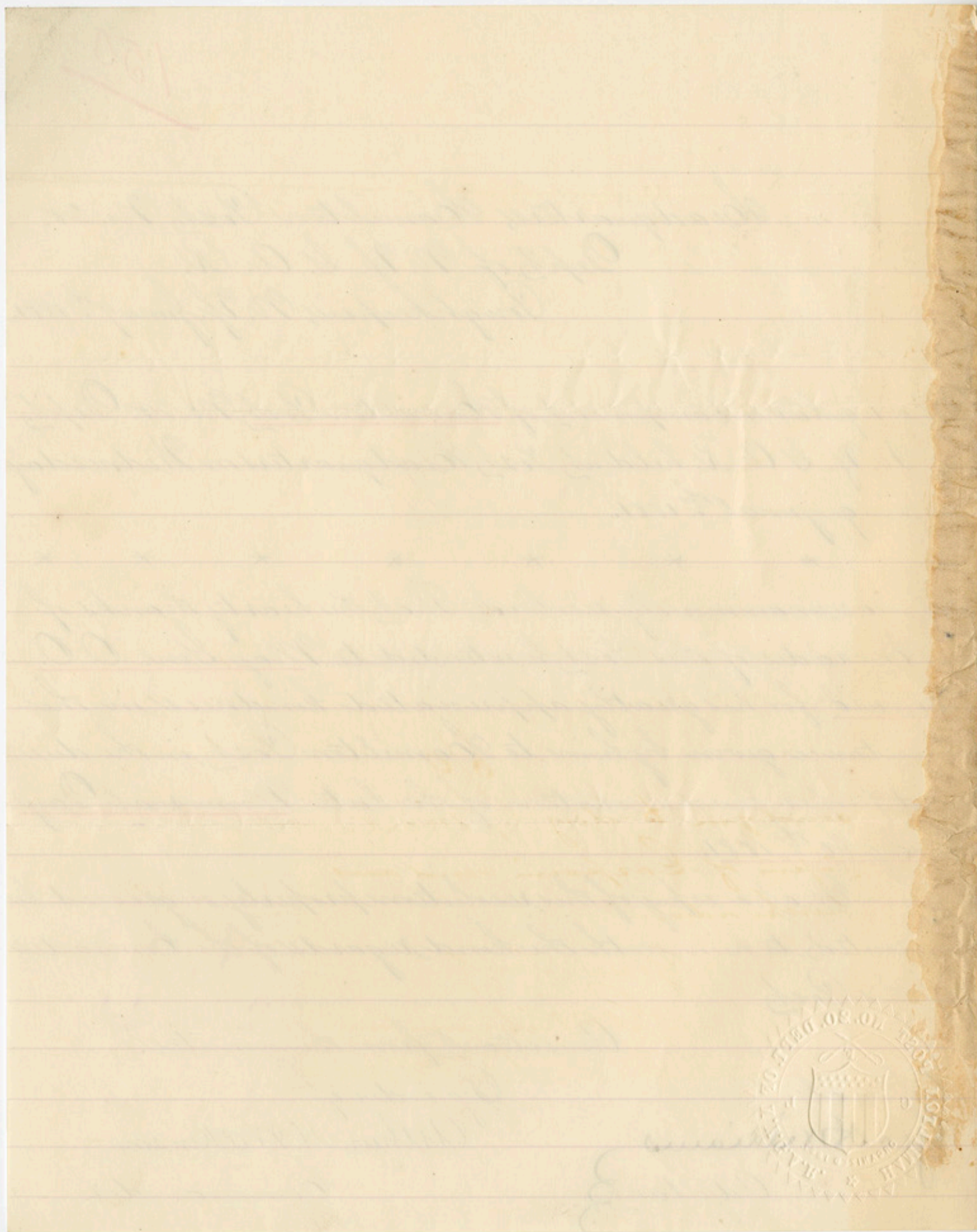

GENERAL ORDER No. 9.

I. As has been stated in General Order No. 8, the Reunion of the Grand Army of the Republic, together with the old soldiers and sailors of the Department of Nebraska, will be held at Beatrice, September 7th to 12th, 1885. The reunion ground embraces over 200 acres, and is two miles from the beautiful city of Beatrice; and, taking all things into consideration, is the finest camp ground we have ever had, being located as it is on the beautiful Blue river, where an old-fashioned army pontoon bridge will span the river between the camp ground and the sham battle field. The U. P. and B. & M. R. R.'s both run through the camp. They will have extensive platforms built for the accommodation of those attending the Reunion.

II. Once more I call the attention of the different Post Commanders to the necessity of reporting as soon as possible all the tents that it is possible for them to furnish said Reunion. Capt. W. C. Henry, Quartermaster of camp, is the proper person to report to. Pack and ship your tents on or before the first day of September, so that they may be pitched and ready to receive you on your arrival. Each comrade will be entitled to occupy his own tent, and at the conclusion of the Reunion they will be packed and re-shipped to him without any charge whatever.

III. The different railroads of this Department have agreed to furnish transportation at the very low rate of one fare for the round trip. Tickets will be sold September 6th to 11th, good to return September 14th, 1885. Comrades, this is a grand opportunity for you to meet your old comrades in arms, and enjoy the best Reunion we have ever had.

IV. The railroads of this Department have extended their very generous offer to furnish free transportation to all uniformed bands in



the Department, upon certificate issued by Post Commanders, and countersigned by the Department Commander; the Seal of the Department to be affixed thereto. In localities where there are uniformed cornet or martial bands desirous of attending the Reunion, the nearest Post Commander to said band will obtain a complete list of the members certifying the same to these Head-quarters, where it will be countersigned by Department Commander, and returned to leader of band; all bands to go to the Reunion in a body and return the same way, and while there will be subject to the orders of the Commander of the camp. They are expected to report for duty on or before Tuesday noon, September 8th, and remain on duty until close of the Reunion, unless excused by the Department Commander. Bands desirous of joining the State Band Association, will report to S. L. Hawley, Secretary, at Central City, Neb. I would recommend that all bands join this Association.

V. The Council of Administration is hereby called to meet at Head-quarters in camp, Monday, September, 7th, 1885, at 7 o'clock P. M., for the purpose of transacting any business that may be necessary in the interest of the Department. All members of said Council are expected to be present.

THE GRAND ARMY MISSION OF THE CITY OF NEW YORK.

(Pension Agency Building.)

The present requirements of the United States Pension laws are found to involve the personal attendance, four times a year, at the Pension Agency in the City of New York, of between twelve and fourteen thousand men, who come there to receive their pension money. Nearly all of these men are veterans, and most of them are members of the Grand Army. The needs of many of these men induce them to arrive during the day and evening before the payments begin, to secure places in line.

Need of a resting place and shelter constrains many of them to resort to saloons, which abound in that vicinity, in which aside from other injurious results, there is practiced a system of cashing the pensioners' checks, which it will be to their advantage to supplant.

This state of things, commencing with the third day of the month, the day before the payments begin, continues to a greater or less extent throughout the entire month, so that it is practically in existence one-third of each year.

To relieve these deserving men and to offer to them at other times a place of Christian fellowship, an un-incorporated organization has been formed under the name of "The Grand

Army Mission of the City of New York." Capt. Killiaen Van Rensselaer is President and Treasurer, General Alexander S. Webb and James Talcott Vice-presidents, and Colonel H. H. Hadley, Secretary and Superintendent. The other Trustees are Gen. O. O. Howard, Col. Frank C. Loveland, General Fred'k T. Locke, Wm. T. Wardwell, John S. Huyler, Henry Hall, Samuel H. Hadley and Gen'l Wager Swayne,

This organization has leased for three years a large basement at Nos. 396 & 398 Canal Street, directly under the pension Agency, and conveniently fitted up. In this room it proposes to maintain throughout the year a strictly undenominational Christian mission, which shall open its doors at all times especially to veterans and Grand army men, and during the months in which pensions are paid shall do its utmost to afford them shelter and a place of rest, and also to cash their checks without cost, to help them in remitting money to their families, and in every practicable way.

The gentlemen above named have assumed the lease and made subscriptions payable in money. Other contributions are needed, and members of the Grand Army and other persons in New York are invited to subscribe sums payable annually, the wish of the organization being to provide a reliable income adequate to the end in view.
