Raleigh Freedman's Savings Bank.

At a meeting held in Raleigh on the 24th of Oct. 1867. to organize a Branch of the National Savings Bank to be chartered under act of Congress the following gentlemen were recommended as follows for Directors;

Geo. W. Simpson. R. W. Pulliam
W. W. Holden. John T. Dewees & James W. Harris.

W. W. Holden was called to the chair and on motion John T. Dewees was appointed Secretary of the Board of Directors.

On motion W. W. Holden was chosen President of the Raleigh Freedman's Savings Bank & James W. Harris, Vice President.

On motion it was Resolved. that R. W. Pulliam Esq one of the Directors, be requested to wait upon Maj. Gen. Howard with the proceedings and to receive from him a Charter for this Institution together with such books, & papers, and information, as may be necessary to put the Institution in immediate operation.

On motion the President and Vice President, were authorized to employ a Cashier for this Bank, and that they also be authorized

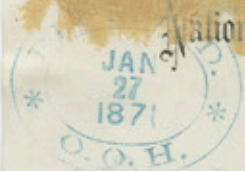
